Prathama and Madhyama examination of Hindi Sahitya Sammelan Prayag (Allahabad)

317. SHRI GHOUSE MOHIUDDIN SHEIKH: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether it is a fact that the persons who have passed the Prathama and Madhyama examination from the Hindi Sahitya Sammelan Prayag (Allahabad) are not allowed to enter in Government services;

(b) if so, what is the $Statu_s$ of this institution;

(c) whether it is also a fact that the Hindi Sahitya Sammelan, Prayag, is not a recognised University and its qualifications are not recognised for recruitment in Government services; and

(d) if so, the reasons therefore?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI P. VENKATASUBBA-IAH): (a) to (d) The Hindi Sahitya Sammelan is a voluntary organisation and not a university or a deemed university. Therefore, these examinations conducted by this organisation have not been recognised as such for entry into Government services. However, the Prathama and Madhyama examinations of this organisation have been recognised as equivalent to SSLC and B.A. respectively, only for the purpose of determining the standard of Hindi where such a standard has been prescribed for any post.
