- 430. SHRI SYED SHAHEDULLAH: Will the Minister of SHIPPING AND TRANSPORT be pleased to state:
- (a) whether it is a fact that no loan has been advanced to Calcutta Port Trust for meeting expenses for the dredging of Shipping Channel to Hal-dia during the last two years; and
- (b) if so, what are the reasons therefor and how it has affected the Port's financial resources?

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI BUTA SINGH): (a) Yes

(b) N₀ loans could be advanced to Calcutta Port Trust pending approval of Revised Cost Estimate for the dredging of shipping channel to Haldia. The Revised Cost Estimate has since been sanctioned and further action for release of loan will now be taken.

(b) A Two Man Committee had been appointee; in October, 1975 by the Central Government to examine in detail and report on the working and financial position of the Calcutta Port and allied matters. The Committee submitted its report in June 1976 and one of the recommendations made by it was to adjust 50 per cent of the

- (b) The Indian Embassy Kuwait has 8 diplomatic officers, 15 memberr of staff and 19 local employees.
- (c) A three-member Special Task Force reached Kuwait on Octob*-1980 to assist our Mission for eva cuating Indian nationals coming from Iraq. One member* of the team re turned to India on November 5, 1880' as th^ work has tapered off. The other two members continue to be there.

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MALLIKARJUN}: (a) There are &84 Inspection Carriages on the Indian Railways. Zone-wise statement is placed at Annexure A'. [See Appendix CXVI, Annexure No. 28], They are considered a part of overall coaching fleet for purpose of repair and

maintenance and haulage and no separate records of maintenance cost and haulage of Inspection Carriages are maintained.

(b) As Inspection Carriages have not been built for a number of years, the present day costs of these Inspection Carriages are not available. The Inspection Carriages now in use have been mostly built between 1900 and 1940 and their average costs, as available in the books, areas under:—
