Plantation Policy of Government (in which Teak Trees are planted instead of Sal) which is stated to have resulted in gradual decline of the daily earnings of the local Adivasis from the forest produce;

(b) whether it is also a fact that police resorted to firing without any warning or lathi-charge or tear-gas, on peaceful Adivasis who were protesting in Gua (in Singhbhum in September last) against the present forest policy;

(c) whether his attention has been drawn to reports about police excesses on Adivasis of that area; if so, the excesses reported and Government's reaction thereon; and

(d) the Government's reaction regarding the demands of these Adivasis and the action taken by Government thereon?
