Gujral Committee Report on Urdu

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION (SHRIMATI SHEILA KAUL): (a) The Gujral Committee Report is being examined in consultation with the State Governments, Union Territories and other Ministries/Departments of the Govt, of India.

- (b) and (c) Comments have been received from the States of Maharashtra, Punjab and Rajasthan and the Union Territory Administrations of Chandigarh and Delhi. State Government of Nagaland and the Union Territory Administrations of Dadra & Nagar Haveli, Lakshadweep, Mizoram Pondicherry have stated that they have no comments to make. The State Governments of Andhra Pradesh, Bihar, Gujarat, Himachal Pradesh, Jammu & Kashmir and Sikkim have stated that the Report is under study and their comments would be available thereafter. Replies from the States of Assam, Haryana, Kerala, Karnataka, Madhya Pradesh, Manipur, Meghalaya, Orissa, Tamil Nadu, Tripura, Uttar Pradesh, West Bengal and Union Terirtory Administrations of Arunachal Pradesh, Andaman & Nicobar Islands, Goa, Daman & Diu; are awaited. They are being remaind-ed regularly.
- (d) An officer has been designated for the purpose.
 - (e) Yes, Sir.
- (f) Since most of the recommendations concern State Govts./Union Territories/Ministries/Depaxtmenta of the Government of India, other than the Ministry of Education, it would not be possible to give any definite date in this regard.

THE MINISTER OF STATE IN THE MINISTRY OF **EDUCATION** (SHRIMATI SHEILA KAUL): (a) The composition of the Advisory Committee for the 1400th Anniversary of Hijra Era is attached. (See below) The Committee was set up in July, 1980 and so far two meetings have been held on 12-7-1980 and 20-9-1980.

- <b) Yes, Sir.
- (c) The Committee has recommended the following programmes: —
 - (i) Issue of commemorative stamp;
 - (ii) Organisation of a Qiraat competition;
 - (iii) A documentary film on the various aspects of Islamic Cultural Heritage of India;

- (iv) A seminar on "Islam's contribution to the culture and civilisation of the world with special reference to India."
- (v) Two exhibitions on Islamic Heritage of India-one consisting of architecture, textiles, furniture, armour, carpets, metal-works, woodworks in the Hall of the Nations in Pragati Maidan and later to be shown in other parts of India as well as abroad; and the second consisting of manuscripts, calligraphy, miniature, precious and semiprecious stones at the National¹ Museum;
- (vi) Allotment of a plot of land by Government in Lodi Estate Institutional area for India-Islamic Centre and laying of the foundation-stone of the centre by the Prime Minister.

It is estimated that the total cost on these programmes would be around Rs. 40.00 lakhs.

Foreign Student_s Studying i_n Indian Universities

743. SHRI SYED SHAHABUDDIN: Will the Minister of EDUCATION be pleased to refer to the reply to Unstarred Question 1408 given in the Rajya Sabha on the 2nd July, 1980 and state:

- (f) what is the number of foreign students receiving school education in India and the number of students of Indian origin included therein?

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION (SHRIMATI SHEILA KAUL): (a) to (c) Information is being collected and will be laid on the Table of the Rajya Sabha.

Statement

Normally it is not necessary for the universities to obtain the prior approval of the Government of Jndia before admitting foreign students other than those sponsored by the Government. However, in order to streamline the procedure for the admission of self-financing foreign students, the Ministry of Education and Social Welfare has requested all the universities in India that the applications of self-financing foreign students seeking admission should not be considered for admission unless they are in possession of Student Visa. The Ministry of External Affairs also requested the Indian Missions abroad to advise all prospective candidates to apply for admission to the Indian Missions and forward the applications of only those eligible candidates who have adequate knowledge of English to this Ministry. On receipt of the applications, this Ministry will forward them to the various Universities/Institutions for consideration for admission. After the admission have been confirmed by the universities/institutions, this Ministry will request the Indian Missions abroad to issue Student Visa to the candidates concerned. In view of this procedure, the universities requested that the were applications of self-finacing foreign students who apply directly
