Establishment of New Sugar Factories

752. SHRI NARSINGH NARAIN PANDEY: Will $_{the}$ Minister of AGRI-CULTURE be pleased to state:

(a) whether Government have any proposal for issuing licences to new sugar factories in the country; if so, the details thereof;

(b) whether it is also a fact that on the basis of recovery the new factories will be given free quota sugar and other relief in excise duties; if so, the details in this regard; and

(c) whether Government have taken a decision to make a departure from its dual price system of sugar; if so, what ar_e the reasons thereof?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI R. V. SWAMINATHAN): (a) The Government have decided to issue licences fo_r establishment of new sugar factories in the country and have issued a Press Note on 4th July, 1980 in this regard indicating the details thereof,, in the shape of guidelines [See Appendix CXIV, Anne-xure No. 55]

(b) Yes. Sir, According t_0 the revised incentive scheme for sugar industry announced by the Government on, 4th October,, 1980, new sugar factories and expansion projects completed at high capital cost in different recovery areas will be eligible f^{or} extra free sale quota of sugar and excise duty relief. The details of the scheme are given in the enclosed statement. [See Appendix CXIV, Anne-xure No. 56]
