THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI KARTIK ORAON): (a) About 10 per cent.

(b) 20 per cent promotional scheme was introduced in 1974 to provide better promotional avenue to the staff (Group 'C and 'D') in the P&T Department. It has been implemented in various cadres of the Department. As regards the . number of beneficiaries in U.P. Circle on Postal side, it is being collected and will be placed on the table of the House.

(c) Yes, Sir. Confirmation of the officials on their posts is done in accordance with the existing rules and orders of the Government.

(d) The number, of confirmation made in respect of LSG, HSG and IPOs in U.P. circle is being collected and will be placed on the Table of the House.

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI BALESHWAR RAM): (a) Information about production and number of persons employed in khadi and village industries, State-wis_e and industry-wise during the year 1977-78 and 1978-79 has been given at pages XXIII to XXXIV and XXXV to XL respectively of the Statistical Statement to Annual Report of the Khadi and Village Industries Commission for those years. The reports have already been placed on the Table of the House. Provisional figures in regard to production and employment in Khadi and Village Industries during the year 1979-80 are given in the enclosed Annexure. [See Appendix CXVI, Annexure No. 49.]

(b) Year-wise estimated projections for 1980-81, 1981-82 and 1982-83 are as follows:—

(c) The following steps are proposed to be taken to accelerate and encourage the production and employment in the Khadi and Village Industries sphere:—

(i) Existing and potential artisans will be identified and their activities diversified.

(ii) The employment base will be widened by expanding and diversifying the existing programmes and taking up additional programmer particularly in areas where need to creat_e employment opportunities is acute and urgent.

(iii) Activities :for procurement, storage and processing of raw materials, manufacture and supply of improved tools and equipment, credit, marketing, training etc. will be promoted and strengthened.

(iv) Setting up of a strong infrastructure for research and development in production and processing technology, product development, diversification of raw materials and processes, designing, improvements in packaging etc with a view to reduce drudgery of work without 61 yVritten Answers

reducing employment and improvement in quality of product and increasing the productivity and earnings of artisans will be taken in ' hand.

(v) Production and supply of improved tools and equipment will be stepped up.

(vi) More emphasis will be placed on transfer of technology and transmission of higher skills by creating training infrastructure.

(vii) Production Centres will be organised in areas where local entrepreneurship is not forthcoming with the long term objective of transferring the centres to the artisans themselves.

(viii) Arrangements will be streamlined for providing critical and scarce raw materials.

(ix) Greater attention will be given to Backward areas and deprived sections of society especially the Scheduled Caste/Scheduled Tribes and- increasing the percentage share in numerical and financial terms of Scheduled Caste/ Fcheduled Tribes and women in KVI activities by making specific allocations for areas and industries which have preponderance of these target groups.

(x) Adequate provision will be made for providing employment to educated unemployed especially among the sections of marginal farmers and landless agricultural labourers by' providing training opportunities to them.

(xi) Marketing organisations will be strengthened.

(d) The nature, content, duration and intensity of employment in Khadi

and Village Industries differs from industry to industry and within an industry from activity to activity. It is, there'iore_i difficult to determine average daily wage paid to a worker engaged in Khadi and Village industries. The wage pattern is broadly as under: —

Khadi spinners can earn about Rs. 3 to Rs. 7 per day. Weavers can earn Rs. 5 to Rs. 10 per day and other artisans like carders, dyers etc. can earn about Rs. 5 per day. Under village industries the daily earning/wages varies between Rs. 3 to Rs. 15 per day *e.g.* a carpenter can earn about Rs. 15 per day whereas collection of non-edible oilseeds, se_a shells etc. may give to an artisan only Rs. 3 to Rs. 4 per day.
