North Eastern Region monitored under Delivery Monitoring Unit (DMU) is available on the website of the Ministry of Development of North Eastern Region. Completion of the ongoing infrastructure projects in these sectors is, *inter-alia*, dependent upon the allocation of adequate funds and the absorption capacity of the concerned states.

## Pending projects of Maharashtra

†2279. SHRI SANJAY RAUT: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:

- (a) whether it is a fact that Vavanthadi and Sondhyatola projects, Samini project, Assauli project, Dogargaon and Itsinagar irrigation projects of Bhandara and Gondia districts in Maharashtra, stick in the laws of Jhurpi forest for very long time, are pending with the Ministry;
- (b) whether MIDC complex in Pawni Tehsil is not being constructed due to this Jhurpi forest law; and
  - (c) the steps being taken by Government to sanction the above projects at the earliest?

THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI JAIRAM RAMESH): (a) Out of the six projects indicated in the question, four have already been approved by the Ministry. Vavanthadi project was approved on 20.04.2010, Sondhyatola project on 15.09.1999, Assauli project on 18.09.2000 and Dogargaon on 22.06.2010. The proposals for Samini project and Itsinagar irrigation project have not been received in the Ministry.

(b) and (c) No such proposal has been received in the Ministry under the Forest (Conservation) Act, 1980.
