2412. SHRI RAM KRIPAL YADAV: Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) the details of amount allocated under Centrally Sponsored Schemes of the Ministry to Bihar during 1998 to 2004 and 2004 to 2010; scheme-wise and year-wise;
- (b) the details of amount released against the above allocation during the above period, scheme-wise and year-wise; and
- (c) the details of amount already spent by Bihar Government against the above allocation and release?

THE MINISTER OF STATE OF THE MINISTRY OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI KRISHNA TIRATH): (a) to (c) Under Centrally Sponsored Schemes of the Ministry of Women and Child Development, funds are released to the State on the basis of the pace of expenditure reported. The entitlement is finally worked out in accordance with the schematic norms and unspent / excess balance in a particular year is adjusted in the subsequent financial year.

The Scheme-wise details of funds released and expenditure reported for the last three years are given in Statement (*See below*). The details of funds released and utilized by the State in the period previous to 2007-08 are also given in the Annual Reports of the respective years of the Ministry. These are available in the Library of Rajya Sabha and may be referred to.
