THE MINISTER OF FOOD PROCESSING INDUSTRIES (SHRI SUBODH KANT SAHAY): (a) to (c) No scheme is being implemented as Centrally Sponsored Scheme by this Ministry. Accordingly, no funds have been allocated to State Governments, including Bihar State. However, in central sector plan schemes being implemented by this Ministry, the financial assistance extended to Bihar State during last three years is given below:

#### **National Broadcast Authority of India**

2320. DR. BARUN MUKHERJI: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

- (a) whether Government proposes to set up National Broadcast Authority of India (NBAI) empowering it to screen programmes or advertisements before broadcast;
- (b) if so, the proposed structure composition and objectives thereof;
- (c) whether it would be authorized to control news contents;
- (d) what other types of content monitoring is proposed; and
- (e) whether Government intends to go back to censorship?
