#### **Funds of Central sponsored schemes in Bihar**

2558. SHRI RAM KRIPAL YADAV: Will the Minister of RURAL DEVELOPMENT be pleased to state:

(a) the amount allotted under Central sponsored including Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) under the Ministry to Bihar during last three financial years, scheme-wise and year-wise;

(b) the amount released against the allotment during the above period, scheme-wise and year-wise;

(c) how much amount have already been spent by the State Government of Bihar against above allotment and released?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI PRADEEP JAIN): (a) to (c) The Ministry of Rural Development implements the major schemes viz., Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA), Swarnjayanti Gram Swarojgar Yojana (SGSY)/ National Rural Livelihood Mission (NRLM) as self employment programme. The Ministry also implements Indra Awaas Yojana (IAY), Pradhan Mantri Gram Sadak Yojana (PMGSY), National Social Assistance Programme (NSAP), Integrated Watershed Management Programme (IWMP), National Rural Drinking Water Programme (NRDWP) and Total Sanitation Programme (TSC) in rural areas through State Governments for overall improvement in living standard of rural households. The fund allocated, released and utilization by the Government of Bihar under these schemes during the last three financial years (i.e. 2007-08, 2008-09 and 2009-10) are given in the Statement.
