(c) The Total Project Cost is Rs. 909 crore. As per Concession Agreement, there is no grant requirement and the entire project expenditure is to be met by the Concessionaire.

(d) and (e) The work is likely to start after the financial closure and is targeted to be completed in 30 months.

- (a) whether it is a fact that toll tax is collected from the users of Delhi-Gurgaon Expressway;
- (b) if so, the date on which this toll tax collection had started;
- (c) the rate at which toll tax was charged from every vehicle at that time;
- (d) the rate of charging toll tax in June 2010; and
- (e) the reasons for increase in these rates?

THE MINISTER OF STATE IN THE MINISTRY OF ROAD TRANSPORT AND HIGHWAYS (SHRI R.P.N. SINGH): (a) and (b) Yes, Sir. The collection of user fee started *w.e.f.* 25.01.2008.

(c) The details of fee charged from different vehicles *w.e.f.* 25.01.2008 to 31.03.2008 are given in the Statement-I (*See below*).

(d) The details of fee charged from different vehicles *w.e.f.* 01.04.2010 to be applicable up to 31.03.2011 are given in the Statement-II (*See below*).

(e) The user fee is revised every year *w.e.f.* 1st April as per Concession Agreement. The increase is as per Gazette Notification based on Wholesale Price Index (WPI) published by Govt. of India.
