#### **Clearing backlog of subsidies to tea industries**

\*353. SHRI T.M. SELVAGANAPATHI: Will the Minister of COMMERCE AND INDUSTRY be pleased to state:

- (a) whether it is a fact that Government has been urged to clear the sizable backlog of subsidies to the tea industry;
- (b) if so, the details thereof and the steps being taken by Government in this regard;
- (c) whether it is also a fact that India's bias towards Crush, Tear, Ourl (CTC) tea had led to a steady erosion of its international market; and
- (d) if so, the details thereof?

THE MINISTER OF COMMERCE AND INDUSTRY (SHRI ANAND SHARMA): (a) and (b) Yes, Sir. Tea Board has reported a backlog of around Rs. 90 crores on account of various development schemes being implemented for the tea sector. The Current year's Plan allocation of Tea Board has been enhanced to Rs.145 crores from Rs. 133 crores last year and out of this Rs. 72.80 crores released to Tea Board which will help in reducing the backlog.

(c) and (d) India is pre-dominantly a producer of CTC teas which largely cater to domestic demand. The Government of India is providing incentives for the production of orthodox tea which is mainly exported. During the last three years, the export of tea has risen both in terms of quantity as well as in value terms as may be seen from the statement given below :-

THE MINISTER OF ROAD TRANSPORT AND HIGHWAYS (SHRI KAMAL NATH): (a) The details of National Highways (NHs) in Haryana are given in the Statement-I (*See below*).

(b) All National Highways in Haryana are being maintained in traffic worthy condition subject to inter-se-priority and availability of funds.

(c) The allocation/ amount earmarked to each State is made for all the National Highways in the state collectively. The details of amount spent on National Highways in Haryana NH-wise during last three years are given in the Statement-II (*See below*).

(d) and (e) Development of National Highways is a continuous process subject to inter-se-priority and availability of funds. The details of National Highways proposed for widening and development under National Highways Development Project (NHDP) are given in the Statement-III.
