## OBITUARY REFERENCE

MR. CHAIRMAN: Hon. Members, I refer with profound sorrow to the passing away of Dr. M.M.S. Siddhu, a former Member of this House, on the 1st June, 2004 at the age of 89 years.

Born at Raipur, District Jullundur, Punjab in June, 1915, Dr. Siddhu had his education at Lucknow Christian College and King George Medical College, Lucknow.

A medical practitioner by profession, Dr. Siddhu was associated with various social, political and charitable organisations. A recipient of Dr. B.C. Roy National Award in 1982, Dr. Siddhu was associated with the Tuberculosis Association of India and the Indian Medical Association. He was President of the All India Institute of Medical Sciences from 1978 to 1980 and re-elected to it in the year 1980. He was also Vice-President of the Indian Medical Association. Dr. Siddhu was elected Mayor of the Lucknow Municipal Corporation in 1969.

Dr. Siddhu represented the State of Uttar Pradesh in this House for three terms, from April, 1962 to April 1968; July, 1977 to April, 1978 and again from April, 1978 to April, 1984.

In the passing away of the Dr. M.M.S. Siddhu, the country has lost a veteran parliamentarian and a dedicated social worker.

We deeply mourn the passing away of Dr. M.M.S. Siddhu.

I request Members to rise in their seats and observe silence for one minute as a mark of respect to the departed soul.
