- (b) As regards the termination order issued by the management, no prior Information was furnished to the office of Chief Labour Commissioner (Central), Ministry of Labour & Employment by the management.
- (c) All India Aircraft Engineering Association (AIAEA) served a strike notice proposing strike on 12th June, 2010 in protest against alleged illegal termination of 13 employees and suspension of 24 employees. Chief Labour Commissioner (Central) intervened in the matter and held conciliation proceeding on 09.06.2010. On the request of Chief Labour Commissioner (Central), the association agreed to call off the strike and discussed the grievance/demands with the management. Chief Labour Commissioner (Central) also advised the management to discuss and resolve the demand amicably on written request received from the association.

Further, Air Corporation Employees Union (ACEU) raised an Industrial Dispute against the alleged termination of 42 employees and reversion of 13 employees from the higher post before Chief Labour Commissioner (Central). Chief Labour Commissioner (Central) intervened in the matter and held conciliation proceedings on 18.05.2010, 08.07.2010 & 23.07.2010. The matter is still under conciliation.

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR AND EMPLOYMENT (SHRI HARISH RAWAT): (a) A details showing the number of lives covered under Aam Aadmi Bima Yojana which is under Ministry of Finance is given in the Statement-I (See below) and a Statement showing the number of BPL families covered under RSBY is given in the Statement-II (See below).

(b) The RSBY has been extended to all Building and other Construction Workers registered under the Building and other Construction Workers (Regulation of Employment and Condition of Service), Act, 1996. At present there is no proposal to extend the scheme to forest workers.
