increased, passport to Haj pilgrims be provided without delay, transparency be ensured in Haj affairs, more powers be given to State Haj Committees and Government Haj quota be reduced, etc.;

- (b) if so, Government's reaction thereto;
- (c) the other matters that were raised therein; and
- (d) the action plan that Government is preparing in all these matters?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI S.M. KRISHNA): (a) Annual Haj Conference is organized every year by the Haj Committee of India and is attended by prominent members of the Muslim community from all over India and other agencies involved in Haj related arrangements. Views and comments are expressed with regard to the arrangements for Haj.

(b) to (d) It is the constant endeavour of the Government to keep making improvements in the arrangements for the Haj pilgrims and provide them with better facilities after taking into account the feedbacks received from all concerned.

(b) The Government of India has approved funds to the tune of Rs.2394 crore to the Organizing Committee for the Conduct of the Commonwealth Games, 2010 including for Overlays, Timing Scoring and Result System and Sports Equipments.

- (c) An amount of Rs. 4460 crore has been approved for upgradation/renovation/creation of sports infrastructure.
- (d) Government of India through the Ministry of Home Affairs/Planning Commission has provided Delhi Government an amount of Rs. 2800 crore, on Plan side, for upgradation of sports and city infrastructure.
