Online PDS scheme

- *99. SHRI N.K. SINGH: Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:
- (a) whether Government is planning to transfer food entitlements to ration card holders through an electronic system once the Public Distribution System (PDS) is linked to Unique ID or Aadhar's central data repository;
 - (b) if so, the salient features of the proposed online scheme; and
- (c) to what extent the fake ration cardholders/beneficiaries are likely to be unearthed by this online PDS scheme?

THE MINISTER OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (SHRI SHARAD PAWAR): (a) to (c) Government has already initiated action to transfer food entitlements through an electronic system to beneficiaries under Targeted Public Distribution System (TPDS) by taking up pilot schemes on Computerisation of TPDS operations and Smart Card based delivery of essential commodities. Action has also been taken to circulate a working paper of Unique Identification Authority of India (UIDAI) on Aadhaar based reforms in TPDS to all State/UT Governments.

The pilot scheme on Computerisation of TPDS operations envisages among others making real-time information available, ensure effectiveness of service delivery, and put in place a grievance redressal mechanism.

In the pilot scheme on Smart Cards, the existing ration cards will be replaced by smart cards which will store biometric features (fingerprints) of adult members of beneficiary families. This is intended to eliminate lifting of TPDS commodities by persons other than the genuine beneficiaries.

'PAU 201' a new rice variety

- *100. SARDAR SUKH DEV SINGH DHINDSA: Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:
- (a) whether Government has directed the Food Corporation of India (FCI) to buy out bulk of the harvest from the 'PAU 201', a new variety of rice, which was damaged to the extent of over eight per cent in Punjab; and
 - (b) if so, the details thereof?

THE MINISTER OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (SHRI SHARAD PAWAR): (a) and (b) The State Government of Punjab, through its agencies, procures wheat and paddy on behalf of Food Corporation of India (FCI) for Central Pool stocks. Government of India formulates uniform specifications for procurement of paddy and rice procurement is done strictly in conformity with these specifications. Uniform Specifications of raw rice for Kharif Marketing Season 2009-10, prescribe the limit of damaged/slightly damaged grains upto 3% and broken grains upto 25%. In view of higher damaged grains in PAU 201 variety rice and based on the request of the State Government, the limit of damaged/slightly damaged grains was relaxed to 4.75% in revenue divisions of Patiala, Faridkot and Ferozepur in Punjab and 4% in rest of the State and relaxations in broken grains was extended upto 28% for the entire state.
