**ANNOUNCEMENT BY CHAIRMAN  
RE: REQUEST OF THE ASSISTANT COMMISSIONER OF POLICE (HQRS) NEW DELHI TO EXAMINE CERTAIN DOCUMENTS IN CUSTODY OF SECRETARY-GENERAL,  
RAJYA SABHA**

MR. CHAIRMAN: I have an announcement to make to the hon. Members and to the House.

I have to inform the House that a request was received from the Assistant Commissioner of Police (H. Qrs.), New Delhi *vide* his letter dated 14-2-1980 to examine certain documents in the custody of the Secretary-General, Rajya Sabha, in connection with the investigation of a case FIR No. 684 dated 28-11-1978 under section 420 of the I.P.C., Police Station Parliament Street, New Delhi, registered on the complaint of Shri Syed Ahmad Hashmi, a Member of this House. I referred the matter to the Committee of privileges for obtaining its views. The Committee, after deliberations, felt that I may permit the police authorities to inspect and make copies (including photostat copies) of the documents mentioned in the letter dated 1st May, 1980 from the Assistant Commissioner of Police (H.Qrs), New Delhi, in connection with the investigation of the case. The Committee also opined that the said documents or copies thereof should not be used or produced before a court of law without obtaining prior permission of the Chairman to that effect.

I have, therefore, permitted the police authorities accordingly, with a caution that my prior permission should be obtained.
