[Shri R. Mohanarangan] having been elected as Deputy Chairman of this House. I understand that he belongs to a very important State of this country, namely, Uttar Pradesh. We, the members of our party, are coming from a particular State, Tamil Nadu. As a man who hag put in 35 years in political field and as a Member who was in the Opposition as well as on the ruling side, we really hope that the interests of other States will also definitely be protected by the newly elected Deputy Chairman of this House There is no use talking about...
