488. DR. RAFIQ ZAKARIA; SHRI MURLIDHAR CHANDRAKANT BHANDARE:

Will the Minister of RAILWAYS be pleased to state:

(a) whether Government have devised any alternative scheme to the abandoned underground railway project for meeting the fast growing demand of commuters in Bombay; and

(b) if so, what are the details in this regard and by when it is likely to be implemented?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHR.1 MALLIKARJUN): (a) and (b) A statement is attached.

Statement

(a) and (b) The long term solution for the transport problem in Bombay is the provision of two new Corridors viz. Corridor VI and Corridor VII as proposed by the Metropolitan Transport Project (Railways) Organisation Bombay. However, the work relating to these new Corridors could not be taken up immediately due to constraint of resources. In the meantime, in order to give some immediate relief to the commuters in Bombay, a small scheme costing Rs. 9 crores related to the construction of a rail fly-over at Bandra and optimi-sation of Harbour Branch was taken up in October 1978 and the work is likely to be completed by middle of 1981'. This will facilitate the movement of commuters living in the residential areas north of Bandra to ttieir place-s of work in the Central Business District near Victoria Ter-mi IUS as well as in the Chembur- Msrikhurd area.

In addition to the above, the M.T.P. (Railways) Organisation

Bombay submitted the trafftc-cum-engineering survey report of Bandra-Kurla Rail Link in October 1978 and are at present conducting techno-eco-nomic feasibility survey for extending the railway line from Mankhurd to Belapur (Panvel Creek) and from Panvel Creek to Panveil Town. The feasibility report is expected to ready shortly.
