Minister expressly denied that Pakistan was engaged in manufacturing an atom bomb.

## Road length area in States and Union Territories

[See Appendix CXV, Annexure No. 43] The National Highways are declared keeping in view certain criteria prescribed for the purpose and the requirements of the country as a whole and not on any State or regional hasis.

## Red Cross relief goods

(a) whether Government's attention has been drawn to the press reports to the effect that Red Cross relief goods worth Rs. 18 lakhs in Bahadurgarh Red Cross Stores and worth many

more at Red Cross stores in Birati-Calcutta Depot including milk powder, milk food, baby food and sugar and fish tins, all imported from foreign countries, have become unfit for consumption due to their having been kept for too long; and

(b) if so, what steps Government have taken to ensure that the present unfit Red Cross relief goods do not find way to markets creating a serious health hazard?

THE MINISTER OF STATE THE MINISTRY OF HEALTH (SHRI NIHAR RANJAN LASKAR): (a) A news item appeared in the Indian Express dated the 5th July, 1980 alleging that huge Red Cross stocks were rotting in stores. This has been contradicted by the Indian Red Cross Society which was published in the Indian Express in its issue of 11th July, 1980.

(b) Does not arise.

## Welfare for agricultural workers' force

Will the Minister of LABOUR be pleased to state:

- (a) whether it is a fact that the agricultural workers force was about 19.2 crores as on 31st March, 1978; if so, what was its strength on the 31st March 1979 and 31st March, 1980, respectively;
- (b) whether Government are aware of their problems of job security, payment of minimum wages, fixing of working hours, workers welfare fund. minimum medical facilities and debt malpractices; and
- (c) if so what steps Government have taken or propose to take to solve these problems?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR (SHRIT. ANJIAH): (a) On the basis of the actual increase of the agricultural workers force between the Census of 1961 and 1971, the projected estimate of the agricultural work force as on 31st March, 1978 was about 19.2 crores and has been further projected to estimate about 19.7 crores as on 31st March, 1979 and 20.1 crores on 31st March, 1980.

(b) and (c) The problems of agricultural labour have been under Government's consideration for some time.

A number of employment beneficiary oriented programmes like the Small Farmers Development programmes, the Drought Prone Areas Programmes, the Integrated Development Programmes, the Desert Development Programme for increasing the employment level of agricultural labour were being implemented in addition to the stricter enforcement of the Minimum Wages Side by side, self-employment motion and entrepreneurship development programme, the Food Work Programme, the rehabilitation programme for bonded labour, Operation Flood II Programme, training programmes for rural youth, etc. are some of the other steps being taken to improve the living conditions agricultural labour.

Recently, the Central Standing Committee on Rural Unorganised Labour, approved a draft legislation for Agricultural Workers. The State Labour Ministers' Conference held on 19th-20th July also recommended the speedy introduction of a Central Legislation for Agricultural Workers. The Draft Central Legislation is under examination of Government.
