THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRIMATI RAM DULARj SINHA): (a) and (b) Government have no information regarding uncensored films imported into the country along with Video Sets or shows being held of these films. The Cinematograph Act; 1952 applies only to public exhibition of cinematograph films.. Only films certified by the Board of Film Censors can thus be exhibited. Public exhibition of uncensored films is an offence under the Cinematograph Aet. Enforcement of the provisions of the Act rests with the State Governments and tie Union Territories.
