Fall in the prices of non-ferrous metals in the international market

SHRI BISHAMBHAR NATH PANDE SHRI PRAKASH MEHROTRA:

Will the Minister of COMMERCE be pleased to state:

- (a) whether it j_s a fact that there has been a steep fall in the prices of most of the nonferrous metal, like copper, lead and zinc in the international market;
- (b) if so, what is the present price of these metals in comparison to the prices prevailing in January, 1980; and
- (c) whether the Mineral and Metal Trading Corporation is being directed by Government to import non-ferrous metals for building a buffer stock before the prices again begin to rise?

THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE) (a) Yes, Sir. The prices of many non-ferrous metals which had been rising steeply during the period from August/September, 1979 to January/February, 1980 have fallen considerably thereafter.

THE MINISTER OF SHIPPING AND TRANSPORT AND TOURISM AND CIVIL AVIATION (SHRI A. P. SHARMA); (a) The report appearing in INDIA TODAY of July. 16-31, 1980 has come to the notice of Government.

(b) The quota of fuel of the Flying Club for their use is 2,000 litres per month computable on a quarterly ba sis. On the 9th May, 1980, no fuel was purchased by the Delhi Flying Club. There has been no increase in the price of aviation gasolene in May, 1980.

in the country for processing and printing of cloth State-wise and the employment generated thereby;

- (b) whether '.here is any estimate made by Government as regards cloth processed per day or total in a year and what percentage of such cloth is printed; and
- (c) whether the Aiyar Commi-tee, which had been asked to g-o into the problems of hand processing units and the employment generated has completed its work; and if so. what are the recommendations of the Committee?

THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a) to (c). A statement is laid on the Table of the House.

Statement

(a: to (c). Since hand processing and printing are entirely in the decentralised sector and small scale sector and a proper survey of the same has not been attempted in the past, it is difficult to give exact figures. The report of the working group constituted under the Chairmanship of Shri Iyer (Rela. Director, Weavers" Service Centre, Bombay) is expected shortly. According to tentative estimates collected by the working Group, 670 hand processing units are reported to be in existence providing employment to about 67.000 persons and these units are mainly in the State_s of Rajasthan and Maharashtra. The estimate of hand printing units in the country is 45,000. providing employment to about 4 lakh persons. Hand processing units are estimated to process 1200 million metres of cloth annually. Similarly, the estimate of hand printed cloth is 1470 million metres Per
