THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI MAGANBHAI BAROT): (a) and (b). Government has not taken a view on the wide range of issues relating to the formulation of national policy on wages, incomes and prices. However, the determination of appropriate incomes, wages and prices will form an intergral part of the next Five Year Plan under preparation.

Setting up of industries based on vast deposits of bauxite, coal and iron ore

THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a) and (b). In so far as bauxite is concerned there is already a project at Korba of the Bharat Aluminium Company Limited—a Government of India Undertaking.

Thermal power capacity of 1380 MW based on coal is at present under construction in Madhya Pradesh.

As regards iron ore, there is a proposal under consideration for setting up a pelletisation plant at an estimated cost of Rs. 84.70 crores utilising iron ore fines from Bailadila Mines. In addition to this, Visakhapatnam Steel Plant proposed to be set up at an estimated cost of Rs. 2256 crores vill utiliue iron ore from the Bailadila lange.
