No theft has been reported during this period from Salar Jung Museum, Indian Museum Calcutta, Indian War Memorial Museum Red Fora. National Museum.

- (b) From protected monuments, the antiquities stolen comprise sculptures, parts of cannon, structural members, etc. From the Nehru Memorial Museum the stolen objects include a bronze lion, a metallic cover of a phot-frame, two wooden toys and a framed photograph
- (c) Only one sculpture of Ganesa reportedly stolen from Chittaurgarh has been recovered.
- (d) The sculpture of Ganesa was found on the day following the theft, lying near the monument from where it was stolen.
- (e) The cases are processed by police investigating agencies. As such this Survey has no information in this regard.
