808. SHRI BALESHWAR DAYAL: Will the Minister of RURAL RECON STRUCTION be pleased to state:

(a) whether Government had received any memorandum from MPs during the last one year regarding indiscriminate transfers of officers from the Head Office of Directorate of Marketing and Inspection, Faridabad to branch office at Nagpur;

(b) whether according to Circular No. F. 16-18/77-Adm, Government of India. Ministry of Agriculture atid Irrigation (Department of Agriculture) dated 8-3-1978, such transfers are not permitted; and

(c) if so, what are the reasons for which some officers have been transferred?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI R. V. SWAMINATHAN): (a) Only one officer has been transferred from Faridabad t_0 Nagpur in the Directorate of Marketing and Inspection, during the last one year. Letters from tw_0 MPs. have been received about this transfer.

(d) whether such an arrangement causes a lot of administrative inconvenience and entails lot of avoidable expenditure; and

(e) if so what steps Government have taken or propose to take to shift back the Office of Adviser to Faridabad?

THE MINISTER OF STATE 17 THE MINISTRY OF AGRICULTURE (SHRI R. V. SWAMINATHAN): (a) Yes, Sir. (The correct name of the organisation is Directorate of Marketing and Inspection).

(c) Agricultural Marketing Adviser is also ex-officio Joint Commissioner (Marketing) to the Ministry and his expert advice is frequently required in marketing and quality control matters and formulation of marketing projects for IDA Credit. He is also required to serve on advisory committees of other department and institution like the Ministry of Foreign Trade, Planning Commission, NAFED, Central Warehousing Corporation, Food Corporation of India etc. This does not, however, come in the way of his devoting adequate time to his office at Faridabad.
