

Marathwada University Centre at Nanded

763. SHRI G. R. MHAISEKAR: Will the Minister of EDUCATION be pleased to state:

(a) whether it is a fact that U.G.C. has granted a Marathwada University Centre at Nanded;

(b) if not, what are the reasons therefor; and since when it has been pending with the UGC; and

(c) by when, the Centre is likely to be established?

THE MINISTER OF EDUCATION AND HEALTH AND SOCIAL WELFARE (SHRI B. SHANKARANAND): (a) to (c) The Marathwada University submitted a proposal to the University Grants Commission in August, 1977 for establishment of a Centre for Postgraduate Studies and Research at Nanded. The proposal as examined by a Visiting Committee and its report as referred to the Commission's Standing Committee on New Universities and University Centres. At its meeting in July, 1978, the Standing Committee expressed the view that the scope and role of University Centres for postgraduate studies should be reviewed and that the consideration of the Visiting Committee's report should be postponed till such a review is done. Following this review, fresh guidelines for postgraduate Centres were formulated and circulated to State Governments and universities in March, 1980. The Marathwada University has not sent any revised proposal so far on the basis of the new guidelines.

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI KARTIK ORAON): (a) The appeal was received in August, 1978 for issue of commemorative stamp in honour of Chhatrapati Shahu Maharaj of Kolhapur. No such request was received for Gadge Maharaj.

(b) The commemorative stamp on Rajarshi Shahu Chhatrapati was issued on 1st May, 1979. The proposal in respect of Shri Gadge Maharaj will be placed before the Philatelic Advisory Committee for consideration in its next meeting.
