THE MINISTER OF EDUCATION AND HEALTH AND SOCIAL WELFARE (SHRI B. SHANKARANAND): (a) and (b) Since many of the recommendations of the Gujarat Committee would have to be implemented by the States, copies of the Gujarat Committee Report have been sent to the State Governments and they have been requested to examine the various recommendations. As the recommendations cover a wide range of subjects, most of the State Governments have asked for extenti-on of time to examine and communicate their views. In so far as this Ministry is concerned, a Committee was constituted to consider those recommendations of the Gujaral Committee Report which can be implemented by this Ministry. It has now been decided to enlarge the scope of this Committee so as to cover the other Ministries of the Union Government.

Teams to study cultural heritage of Himalayans

(a) whether it is a fact that a three fiveyear survey teams were deputed to visit Ladakh, Himachal Pradesh and Arunachal Pradesh to study and preserve the Cultural heritage of the Himalayas contained in the manu. scipts, paintings and relics;

(c) if so, what are the recommendations made in the survey reports?

THE MINISTER OF EDUCATION AND HEALTH AND SOCIAL WELFARE (SHRI B. SHANKARANAND): (a) No. Sir. However, on request from All India Frontier Bauddha Mahasabha the Government of India gave financial assistance to them, during 1979-80 for meeting expenai-ture on, amongst other things, T.A./ D.A. to the members of the three survey teams sent by them to Ladakh, Himachal PradesH and Airunachal; Pradesh for extensive tours in the areas concerned under their project "Survey of Manuscripts & antiquities for the preservation and presentation of the Cultural Heritage of the Himalayan Regions".
