THE MINISTER OF STATE IN THE (SHRI MINISTRY \mathbf{OF} HEALTH NIHAR RANJAN LASKAR): (a) Yes, Sir.

(b) and (c) A large number of firms dealing with Unani medicines were considered for appointment as local chemist. But they expressed their inability to supply all items of Unani medicines included in the formularly of Unani medicines used in the C.G. H.S. dispensary, Sarojini Nagar, New The appointment of a local chemist is in the last stages of settlement.

Complimentary railway passes for newsmen

(a) whether it is a fact that Government issue railway complimentary passes and extend other facilities to newspapermen and writers to study working of the railways:

- (f) whether Government have received any letter from Member of Parliament in this regard?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS SHRI MALLIKARJUN): (a) Yes. With a view to earn publicity the railways issue complimentary passes and extend other facilities to selected journalists and reporters to enable them to visit and report on the various developmental projects and achievements of the railways.

- (b) Information is being collected and will be laid on the Table of the Sabha.
 - (c) No.
 - (d) Does not arise.
- (e) Yes In April 1980, a request was received through the Central Railway from the Chief Reporter of Times of India, Bombay only (and none from Rail India) requesting for a free complimentary 1st Class pass for self and a lady reporter to visit Panchmari, Mhow. Nainital, Darjeeling, Mussoorie, Puri and Simla for the purpose of writing an article on places tourist interest. It was felt that their visit to these places would not earn

the railways any substantial publicity and therefore the request was regretted.

Raising of Kashmir issue by Pakistani leaders

1119. SHRI N. P. CHENGALRAYA NAIDU:

SHRI K. L. N. PRASAD:

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether Government's attention has been drawn to the news item appearing in Hindustan Times of 23rd July, 1980 regarding Kashmir;
- (b) if so, what are the details thereof:
- (c) whether Government have made it clear that Kashmir is part of India and cannot be made an issue; and
- (d) if so, what are the reasons for which Pakistan leaders have been referring to the Kashmir issue everywhere and whether India has made it clear that Kashmir question has long been settled?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMHA RAO): (a) Yes, Sir.

(b) The news item is based on an interview Pakistan Foreign Minister Mr Agha Shahi had with the magazine New Delhi'. According to the interview, the Pakistan Foreign Minister is reported to have said inter alia, that "if we can settle the Jammu & Kashmir question on a basis of freindship, there will be a radical transformation of the entire situation in Asia and the world.": that "the Agreement provides for discussions on Jammu & Kashmir with a view to final settlement "and that" unfortunately our Indian friends have always accused Pakistan-whatever be the regime, military or political that they harp on plebiscite or self-determination for Kashmir in order to ensure their survival or continuance in power"

(c) and (d) The position of the Government of India in regard to Kashmir is well-known, namely, that the State of Jammu & Kashmir is legally and constitutionally an integral part of India. Government would not like to speculate on the reasons for references to Kashmir by Pakistan leaders. However, it has been conveyed to Pakistan on several occasions that their references to Kashmir in international fora are not in conformity with our understanding of the Simla Agreement and will not help in creating a better atmosphere.
