

(c) the steps Government are taking so that adequate education for Urdu language and further upgradation of its standard is ensured?

**THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MD. ALI ASHRAF FATMI):** (a) to (c) It is primarily the responsibility of State Governments to ensure that adequate facilities for imparting primary and upper primary Urdu education are available for the benefit of the Urdu speaking population. The Government of India, in the Ministry of Human Resource Development, implements a Central Scheme for appointment of language teachers, including Urdu teachers. Under this scheme financial assistance is provided on a normative basis to States and Union Territories for those blocks and districts where there is concentration of educationally backward minorities. Financial assistance under Sarva Shiksha Abhiyan (SSA) is also given to Madrasas and Maktabas.
