THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI BUTA SINGH): (a) National Union of Seafarers of India, Bombay, and National Union of Seamen of India, Calcutta, are the recognised Unions of seamen in the country; and

In case however, there ig any other claim by a rival Union and it is difficult to ascertain as to which is the representative Union, the matter is referred t_0 the Ministry of Labour for verification and recognition is granted on the basis of their recommendation.
