Trade unions of seamen

1078. SHRI O. J. JOSEPH: Will the Minister of SHIPPING AND TRANS-PORT be pleased to state:

- (a) what are the names of the recognised Unions/Federations of seamen in the country; and
- (b) what is the criterian adopted for recognition of unions of seamen in the country?

THE MINISTER OF STATE IN MINISTRY SHIPPING OF AND TRANSPORT (SHRI BUTA SINGH): (a) National Union Seafarers of India, Bombay, and National Union of Seamen of India, Calcutta, are the recognised Unions of seamen in the country; and

(b) The recognition is granted by the Shipowners i.e. the employers. In case however, there is any other claim by a rival Union and it difficult to ascertain as to which is the representative Union, the matter is referred to the Ministry of Labour for verification and recognition granted on the basis of their recommendation.
