gear etc. manufactured by a number of other companies are also procured by the project authorities for the power stations. For satisfactory operation of the power plants, all the equipment have to perform satisfactorily in the designed manner. Malfunctioning of any part of the equipment can partly or wholly affect the performance of the power plant. As per reports received from the various State Electricity Boards, some of the auxiliaries like burner titling mechanism, primary air and induced draft fans, dust seal guards of coal mills etc. in the case of boilers, turbo-visory ' equipment, emergency stop valve, automatic Voltage Regulators, steam ejectors etc. in the case of turbogenerators etc. have not been functioning very satisfactorily.

(b) It is not generally possible to quantify the losg incurred as a result I of malfunctioning of some of the components of the generating equipments or other auxiliary systems of a power pisnt. Detailed discussions have been held by th<sub>8</sub> concerned State Electricity Boards with BHEL and other suppliers regarding the problems being faced by the State Elec- > tricity Boards. CEA have also brought these defects to the notice of quality assurance wing of BHEL who have initiated remedial measures based on the feed back given by Central Electricity Authority.

- (c) The allocation of newsprint quota varies not only from year to year but also is revised within the licensing year. The variation is not in any fixed proportion. It is related to the changing level of consumption. Hence, the Ration Card system may not be quite feasible. Another relevant factor is that at present the distribution point i.e. the number of depots of States Trading Corporation for issue of newsprint, is limited. However, Government is fully aware of the need to make the lifting of newsprint easier for the newspapers, especially small and medium newspapers, and a number of steps including cloning of more distribution points i? being studied.
