

### Coal supply to Tamil Nadu

\*265. SHRI R. MOHANARANGAM:  
Will the Minister of ENERGY AND COAL be pleased to state:

(a) whether it is a fact that Tamil Nadu is not being given adequate supply of coal;

(b) whether it is also a fact that at times, due to non-availability of wagons, supply of coal to the State has been held up for months together; and

(c) if so, what steps Government propose to take to remedy the situation?

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI VIKRAM MAHAJAN): (a) to (c) There has been some shortfall in the supply of coal to meet the demand in Tamilnadu, due to inadequate availability of transport capacity particularly railway wagons to move coal to the State. The coal companies are in constant touch with the Railways to maximise the movement of coal by railway wagons including coal to Tamilnadu. The loading of railway wagons is also being currently monitored at the highest level by the Cabinet Committee on Industrial Infrastructure. The coal companies also release coal for movement by road to the consumers against the shortfall in rail movement. The constraint on movement of coal through rail-cum-sea route via Haldia has also affected movement of coal to Tamilnadu.

Government was smuggling it into other States.
