Based on appointment of new distributors, adjustment of areas is undertaken, if considered necessary, BO ."as to ensure economic anl efficient functioning of the distributorships.

(b) and (c) Representations for rationalisation of areas are received and duly considered by oil companies for taking remedial action.

(d) Areas of operation of LPG distributors is defined in their appointment letter. However, in exceptional cases due to lack of potential in their original marketing areas, their area of operation is extended.
