(b) whether there are some oustees, where building is halfcovered by the Dam and the rest which remained with the oustees has been irreparably damaged due to seepage and rendered dangerous and unusable;

(c) whether other structures around the dam have also been badly damaged and their foundations rendered loose so much so that they have become dangerous and uninhabitable; and

(d) if so, whether any compensation is also proposed to be paid to the affected persons falling under (b) and (c) above, if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI VIKRAM MAHAJAN): (a) Yes, Sir.

(b) No such case is in the notice of the Project Administration.'

(c) and (d) There are four cases in village B Dhameta which are under observation by the Project authorities regarding damage which could be either due to natural causes or due to rise of water in Beas reservoir. Any case which is found to be affected due to rise of water in the reservoir will be acquired and paid for.

Will the Minister of PETROLEUM, CHEMICALS AND FERTILIZERS be pleased to state:

(a) what is the total quantity of crude oil and petroleum products proposed for imports for the financial year 1980-81;

(b) whether firm arrangements have been made and

(c) if so, what are the details in this regard?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI VEERENDRA PATIL): (a) to (c) Our total imports of crude oil and petroleum products are likely to be of the order of 16.0 million tonnes and 6.5 million tonnes respectively during 1980-81. No difficulties are envisaged in the import of our full anticipated requirements of crude oil and petroleum products during 1980-81.

It would not be in the public interest to disclose further details.

Redevelopment scheme of Kingsway Camp

1240. SHRI JAGDISH PRASAD MATHUR: Will the Minister of SUPPLY AND REHABILITATION be pleased to refer to the answer to Unstarred Question No. 1069 given in the Rajya Sabha on the 16th May, 1979 and state:

(a) what steps have since been taken by Government, to expedite the execution of the Redevelopment Scheme of Kingsway Camp, Delhi;

(b) whether Government have taken vacant possession of one-room tenements in Outram Line and Hudson Line from all those persons who have been allotted alternative plots under the redevelopment scheme in Dr. Mukherji Nagar; if so, what is the number of such persons;

(c) if not, what are the reasons therefor and what steps are now proposed to be taken in this regard; and

(d) whether Government propose to take action against the authorities responsible for delay in taking possession of these tenements since 1972?

THE DEPUTY MINISTER IN THE MINISTRY OF SUPPLY AND REHABILITATION (SHRI P. K. THUNGON): (a) Since the Scheme is

primarily a slum clearance scheme, the Government have on reconsideration, (Joeided to leave the question of its further implementation to the concerned agencies as part of their normfil activities.

(b) to (d) The allottees of plots were required to hand over vacant possession of one-room tenements within one year. The Municipal Corporation of Delhi has so far taken over possession of 45 tenements. There are still 800 tenements the vacant possession of which is yet to be taken. The Municipal Corporation of Delhi is taking appropriate steps in the matter.

जिला/राज्य स्तर के अधिकारियों को बांधों सहित बाढ़-नियंत्रण बक्स का निरीक्षण करने के निदेश दिए गए थे ताकि इस बात को सुनिश्चित किया जा सके कि वे ठीक-ठीक हैं और बाढ़ मौसम के प्रारम्भ होने से पहले सभी निकास नालियों को ठीक ढंग से सफाई की जा सके। प्रभावकारी ढंग से बाढ़ का मुकाबला करने और बाढ़-सहायता पहुंचाने के लिए अपेक्षित अन्य आपातकालीन उपायों के लिए भी अनुरोध दिए गए थे। राज्य में बाढ़ की स्थिति का सामना करने के लिए किए गए प्रबन्धों के पुनरीक्षण के लिए उत्तर प्रदेश के मुख्य सचिव की अध्यक्षता में 7 जून, 1980 को एक उच्च स्तरीय बैठक भी हुई थी।
