Diamond Export Racket

Equalisation of Cotton Price

*286. SHRI S. KUMARAN: SHRIMATI PRATIMA BOSE: SHRI KALYAN ROY:

Will the Minister of COMMERCE be pleased to state:

(a) whether Government are aware that absence of equalisation of the price of raw cotton is seriously affec. ting the production cost and profitability of the National Textile Corporation and other textile mills in the entire Eastern region; and

(b) whether Government propose to consider the question of equalisation of cotton price and if not, what are the reasons therefor?

THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a) to (b) The working results of mills located, in Eastern Region would be to some extent affected by the freight incidence on cotton, as it is not grown in the East But this is equally true of any mill anywhere else in India which uses that variety of cotton which is not grown in its respective area. A Planning Commission study has indicated that freight incidence on cotton as part of cost of manufacture of textiles 'is insignificant. Two studies made by the Planning Commission have considered it inadvisable to introduce equalisation. 1000
