\*290. SHRI SANTOSH KUMAR SAHU: Will the Minister of FINANCE be pleased to state:

- (a) whether Government propose to formulate a national policy on wages, income and prices; and
- (b) if so, what are the details in  $thi_s$  regard?

THE DEPUTY MINISTER IN THE MINISTRY OP FINANCE (SHRI MAGANBHAI BAROT). (a) and (b) Government has not taken a view on the wide range of issues relating to the formulation of national policy on wages, incomes and prices. However, these issues are expected to come <sup>U</sup>P for consideration in the course of the formulation of the next Five Year Plan.

Mills Limited and how many of them have been provided accommodation by the company till March, 1980;

- (b) whether the employees have encroached upon the land lying vacant belonging to the said company, if I so, what are the details thereof; and
- (c) whether there is any proposal under Government's consideration for the construction of quarters etc. on the said land?]

#### Mineral based industries in Orissa

- \*292. SHRI PATITPABAN PRADHAN: Will the Minister of STEEL AND MINES be pleased to state;
- (a) the proposals regarding various mineral based industries submitted by the Government of Orissa since 1977; and
- (b) what action has been taken so far in this regard till date?

THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a) and (b). Since 1977, six proposals have been received in the Ministry of Steel and Mines for mineral-based industries in Orissa. Details -of these proposals and action taken thereon are indicated in the Statement laid on the Table of the House.

#### Statement

### Mineral Based Industries in Orissa

- M/s. Industrial Promotion and Investment Corporation of Orissa Ltd. had submitted an application on 26-3-77 for the manufacture of sponge iron for an annual capacity of 3,00,000 tonnes. A letter of Intent was granted to M/s. IPI.COL on 5-10-77 which was subsequently converted into an Industrial Licence on 28-6-79. The Industrial Licence is now valid 37-6-81.
- (ii) M/s. IPICOL had submitted another application for an Industrial Licence on 19-1-80 for manufacture of sponge iron for an annual capacity of 90,000 tonnes. The application has been rejected prima facie on the ground that M/s. IPICOL still have an unimplemented capacity of 1,50,000

(1.5 lakh) tonnes per annum out of the Licence referred to in (i) above.

to Questions

- (iii) M/s. IPICOL have also submitted an application on 4-4.78 for manufacture of Ferro Vanadium and Low Phosphorus Pig Iron. A letter of Intent has been issued to M/s. IPICOL for manufacture of 480 tonnes of Ferro Vanadium and 48,000 tonnes per annum of low Phosphorus Pig If on. The validity of the letter of Intent has been extended upto 29-12-80.
- M/s. Industrial Development (iv) Corporation of Orissa Ltd. (IDCOL) have submitted an application on 3-12-79 for an Industrial Licence for the manufacture of High Carbon Ferro Chrome and Ferro Silicon on 3-12-79 for an annual capacity of 25.000 tonnes Per annum. The application has been rejected prima facie on 18-4-80 on the ground that there is no scope for creation of additional capacity, as adequate capacity has already been created.
- (v) M/s. Orissa Mining Corporation have submitted an application for manufacture of High Carbon Ferro Chrome/Charge Chrome for an annual capacity of 50,000 tonnes per annum on 24-12-77. They have been granted a Letter of Intent on 26-5-79 for manufacture of 50,000 tonne<sub>s</sub> per annum of Charge Chrome. The validity of the Letter of Intent has now been extended upto 25-4-81.
- (vi) M/s. Navin Udyog Private Ltd. submitted an application in May, 1978 for grant of an Industrial Licence for setting up a 3,000 tonnes per annum magnesium plant in Orissa. The applicant required foreign collaboration for manufacture of magnesium. The State Government recommended the application. The Licensing Committee rejected the application on the ground that there is no scope for licensing additional capacity and export-oriented power intensive project.
