THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a) to (c) Silicon grade steel is already being produced in Rourkela Steel Plant and TISCO. A new unit under the Silicon Steel Project is under construction at Rourkela Steel Plant with a capacity to produce annually 37,500 tonnes of cold rolled grain-oriented sheets and 36,000 tonne? of cold rolled non-grain oriented sheets.

Stainless steel in being produced by Alloy Steel Plant, Durgapur of Steel A Authority of India Limited as also other units like Visvesvaraya Iron and Steel Works Ltd., Bhadravati and Mahindra Ugine Steel Company. The new steel plant at Salem will also produce cold-rolled stainless steel strips from imported hot-rolled stainless steel bands in the first stage, the annual capacity being 32,000 tonnes.

Super-special alloys are planned to be produced by Mishra Dhatu Nigam (MIDHANI), Hyderabad.

Steel Authority of India Limited plants and TISCO do not produce any of these items specifically for defence purposes, but allotments are made for defence requirements.
