

**Funds allocated to centrally run educational institutions**

4068. SHRI T.T.V. DHINAKARAN: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) the details of the funds allocated for the Centrally run educational institutions during the last three years, State-wise;

(b) whether Government have any proposal to open more educational institutions including the schools during the Tenth Five year Plan period; and

(c) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MD. ALIASHRAF FATMI): (a) In many of the cases, funds are not allocated by the Government directly to the centrally administered educational institutions. The Kendrya Vidyalayas (KVs) and Navodaya Vidyalayas (NVs) are administered by the Kendrya Vidyalaya Sangathan and Navodaya Vidyalaya Samiti respectively, for which central allocations are made. The Central Tibetan School Administration (CTSA) runs, manages and assists institutions set up for the education of Tibetan children in the country. Similarly, funds are allocated to University Grants Commission, which, in turn, distributes the funds to the various Universities/Colleges including the Central Universities. For institutions like Indian Institute of Technology (IITs), Indian Institutes of Managements (IIMs), National Institute of Technology (NIT) etc. block allocations are made, and funds are allocated to individual institutions based on their requirements and availability of resources. A Statement indicating the scheme-wise Annual Plan allocation (Budget Estimate), for the major centrally administered educational institutions/schemes, during the years 2003-04 to 2005-06 is enclosed as a Statement (See below).

(b) and (c) Expansion and opening of new educational institutions is a continuous process. The major proposals during the Tenth Five Year Plan include setting up of new KVs and NVs, a new Indian Institute of Management (IIM) in the North-Eastern Region and a Central Institute of Technology in Kckrajhar.
