THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE AND DEPARTMENTS UNDER THE CHARGE OF THE PRIME MINISTER (.SHRI C. P. N. SINGH): (a) and (b) Between 22nd and 25th June, 1980, a massive land-slide blocked the river Teesta near a place called Naga (at KM 81.5) on North Sikkim Highway. The site was inspected by a team including experts from the Geo'.o Survey of India, Border Roads Organisation etc.

The turbulent configuration burst between 2nd and 3rd August, 1980 washing away a bailey bridge and portions of the road nearby and causing extensive damage as well as disruption of traffic. Urgent short-term measures for restoration of pedestrain traffic have been completed, and of light vehicular traffic are in himd. The site conditions being still unstable, long-term measures are not feasible cr expedient at present; and will be considered as early as possible after a detailed study.
