The number of labourers employed by a contractor depends on the at any point of time, the volume of work time schedule according to which the is required to do the job and contractor therefore the number of labour employed by the contractor varies from time The number of such labour employed by the contractor is, therefore, not available with the Food Corporation of India. In 42 of the Corporation's depots and in the major ports, the work of loading, unloading etc., is done by departmental labour. number of such labour, at present, is 16,013. In another 47 depots of the Corporation, the system of 'direct payment' is in forme. The number of Labourers working in these depots is about 2,743.

(c) Handling contractors are appointed by FCI on the basis of lowest tender received and the work of loading, unloading, stacking and weighment is carried out by the labour engaged by the contractors. The remuneration paid to the contractors is as per contract entered into with them.

The FCI do not have information regarding per bag cost of loading/ unloading in respect of these contractor's labour. According to the data available with the FCI, pertaining to the year 1977-78, the cost of handling foodgrains by the departmental labour was much higher than the cost under the contract system.
