Scheme to Train cooks by the Food and Nutrition Board

(a) whether the Food and Nutrition Board has evolved any Scheme to train persons in cooking nutritious and hygienic food for mass consumption at marriages and other social functions; and

(b) whether the foodcraft courses are also being devised to cater to the needs of the average urbanite?

THE MINISTER OF AGRICULTURE AND RURAL RECONSTRUCTION (RAO BIRENDRA SINGH): (a) and (b). The Government of India, in consultation with the State Govern-; have set up four Institutes of Hotel Management, Catering and Ltiön at Delhi, Bombay, Madras and Calcutta and a number of Food-craft Institutes in different parts of the country for professional training in Hotel Management, General Food Management and Catering Technology and in related specific fields. Training in the craft of Cookery is an important part of the curriculum. The persons so trained are equipped to hygienically handle bulk cooking in hotels, restaurants, airlines and railway catering, industrial canteens and institutional feeding programmes. They are also competent to handle mass cooking at marriages and other social functions.
