Construction of Government Buildings in Delhi

277. SHRI HUKMDEO NARAYAN YADAV: Will the Minister of WORKS AND HOUSING be pleased to state what is the number of Government buildings in Delhi, construction of which is likely to be completed by the end of the current financial year, and what is the amount estimated to be spent thereon?

निर्माण और आवास मंत्री (श्री पी० सी० सेठी) : निर्माण और आवास मंत्रालय के द्वारा लगभग 47 करोड़ रुपये की कुल लागत से कार्यालय और आवासीय भवनों सहित लगभग 9000 सरकारी भवनों के निर्माण कार्य चालू वित्त वर्ष की समाप्ति तक पूर्ण हो जाने की सम्भावना है बशर्ते कि दुर्लभ भवन निर्माण सामग्री उपलब्ध होती रहे।

residential buildings by the Ministry of Works and Housing at a total estimated cost of approximately Rs. 47 crores is likely to be completed by the end of the current financial year, subject to availability of critical building materials.]

Furnishing of Ministers' bungalows

278. SHRI HUKMDEO NARAYAN YADAV: Will the Minister of WORKS AND HOUSING be pleased to state:

(a) what is the amount fixed for furnishing Ministers' bungalows;

(b) what is the expenditure incurred on furnishing the bungalows of each Union Minister during the last three years; and

(c) what is the yearly losses during the last three years due to changes in furnishings of these bungalows?

निर्माण और आवास मंत्री (श्री पी० सी० सेठी) : (क) मंत्री और उप-मंत्री निःशुल्क फर्नीचर और विद्युत उपकरण के लिए क्रमशः 38,500 रुपये और 22,500 रुपये तक की अधिकतम सीमा तक के पात्र हैं।

†[THE MINISTER OF WORKS AND HOUSING (SHRI P. C. SETHI): (a) A Minister and a Deputy Minister are entitled to free supply of furniture and electrical appliances of the maximum value of Rs. 38,500 and Rs. 22,500 respectively.

(b) Statements showing expenditure incurred on furnishing the bungalows occupied by the Union Ministers during the years 1977-78, 1978-79 and 1979-80 are attached. [See Appendix CXV, Annexure No. 30].

Dislocation of telephone services due to rains in Delhi

279 SHRI DHARAMCHAND JAIN: Will the Minister of COMMUNICATIONS be pleased to state:

(a) what is the approximate number of telephones still lying dead in each exchange in Delhi as a result of rains;

(b) what is the corresponding number of phones set in order during the same period, Exchange-wise, and

(c) what action Government have taken to repair the remaining phones?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI KARTIK ORAON): (a) As on 28-7-80 a total of 2812 Telephones are still faulty in Delhi due to Cable failures caused by rain.

(b) The period for which information is required is not mentioned in the question. The first detailed analysis made on 2-7-80 showed that 15550 telephones were affected on that date as a result of rains. Subsequent faults have been occurring but the exact total figures are not available as each (jay clearances are made daily and only the net position of faults is watched as indicated above i.e., 2812 telephones out of order on 28-7-80. The detailed break-up is indicated in Annexure. (See below).

(c) The fault repair work of telephones affected due to cable failures is being done on round the clock basis.
