- (e) if so, how many copies are being printed and when they are likely to be distributed to subscribers;
- (f) what are the reasons for delay in publication of the directory; and
- (g) whether any steps has been taken to publish the directory regularly every year and if not, what are the reasons therefor?

- (c) Yes. First supplementary published in Nov. 78 and number of copies printed—40,000. Second supplementary was published in August, 1979 and number of copies printed—30,000.
- (d) and (e) Yes. 1,90,000 copies are under print and are likely to be distributed by the end of August, 1980.
- (f) (i) Strike in Shri Saraswati Press, Calcutta and (ii) Non-availability of printing paper.
- (g) Steps have been taken to print the directory on schedule.
