

Expenditure on land reform sector for Madhya Pradesh

380. SHRIMATI RATAN KUMARI: Will the Minister of PLANNING be pleased to state:

(a) what was the percentage of cost expenditure for land reform sector for Madhya Pradesh as against the total cost expenditure during the last Five Year Plan period;

(b) what allocation is proposed to be made in the current Five Year Plan;

(c) whether the allocated cost expenditure is in accordance with the priorities fixed for land reforms; and

(d) if not, what are the reasons therefor?

THE MINISTER OF PLANNING (SHRI NARAYAN DUTT TIWARI):

(a) The Fifth Five Year Plan (1974—79) was terminated one year earlier and as such was in operation only for a period of four years 1974—78. During 1974—78, the State Government has reported an expenditure of Rs. 5.67 crores for land reform measures out of a total expenditure of Rs. 1058.00 crores under the State Plan as a whole. The percentage of this expenditure to the total Plan expenditure works out at approximately 0.53.

(b) to (d). The Sixth Five Year Plan 1980—85 is currently under formulation and sectoral outlays have not yet been determined.
