(c) The matter is under consideration.

## Importing of power generating plants

360. SHRI SATCHIDANANDA: SHRI R. M. DESAI:

Will the Minister of INDUSTRY be pleased to state:

- (a) whether there is a proposal under Government's consideration to import power generating plants;
- (b) if so, what i<sub>s</sub> the number of such plants and countries from where these are to be imported;
- (c) whether these plants are being imported by negotiations or through international tenders;
- (d) whether it  $j_s$  also a fact that such plants are readily available with the BHEL; and
- (e) whether the import of such plants would affect indigenous manufacture and also the working of the BHEL?

THE MINISTER OF STATE IN THE MINISTRY OF **INDUSTRY** (SHRI CHARANJIT CHANANA): (a) to (c). Proposals are received by the Government from time to time from the State Electricity Boards and other Electricity Authorities for the import of power generating plans. These imports are sought under the liberalised import policy of 1978 by floating global tenders which are considered by the Empowered Committee; by global tenders in the case of IDA financed projects and also through bilateral negotiations. Each proposal is considered on a case to case basis under the respective prescribed procedure.

- (d) By and large, BHEL is in a position to meet the country's demand for power generation equipment.-
- (e) While considering each proposal for import of power generation equipment, all relevant aspects including the availability of indigenous capacity, is given due weightage.
