### Setting up of Atomic Power Plants

\*127. SHRI N. F. CHENGALRAYA NAIDU: Will the PRIME MINISTER be pleased to state:

- (a) whether it is a fact that two more atomic power stations are proposed to be set up in the country;
- (b) if so what are the places where these power plants are proposed to be set up;

Details in respect of the number of stations and the estimated costs thereof are being worked out. It is proposed to start work on one atomic power plant during the current financial year.

(e) The power generation capacity of a station with two units will be 2 x 235 i.e., 470 MWe.

There are a large number of varieties of paper and no authentic information is available with regard to the exact amount of rise in price. Statutory prices have been stipulated only for white printing paper and cream wove/laid paper. While there has been no change in the statutory price of white printing paper recently, the statutory price of cream
