## GREETINGS TO THE INDIAN TEAM TO MOSCOW OLYMPICS, 1980.

SHRI BHUPESH GUPTA (West Bengal): Sir, I have been very grateful to the Chairman for giving me permission—this is not a Special Mention—on the last day of this session.

(Interruptions)

THE VICE-CHAIRMAN (SHRI R. R. MORARKA): Order, please.

SHRI BHUPESH GUPTA: I rise, Sir, to offer congratulations and send our best wishes to our athletes, sportsmen and sportswomen who are going to participate in the 22nd Olympic Games in Moscow—the games to be held for the first time in a socialist country.

Sir, the games begin there on July, 19. Our delegation, I am told, is leaving on July 12th. In these Olympics there will be 12,000 participants from more than 85 countries, including number of countries of the third world participating for the first time in such Sir, we send our greetings games. and best wishes to the organisers, particularly the Soviet Olympic Committee which is hosting games.

In April last I had the honour visit the Moscow Olympic Village and was deeply impressed by the excellent, massive arrangements for the stay of the participants and for the games. All arrangements have been made in the best traditions of the Olympic Charter, and I am confident that the Moscow Games will set a new record. I am also confident that our Indian team will come out with flying colours.

The Moscow Olympics assume parti cular significance today because marks the triumph not only of international sport but also of international **co-**operation and of peace, The U.S. President, Jimmy Carter's "boycott the Olympics" policy has met with defeat so much so that even many of the NATO countries are participating in the games.

THE VICE-CHAIRMAN (SHRI R. R. MORARKA): Permission was to convery greetings and best wishes to our So, please confine vourself to that only.

SHRI BHUPESH GUPTA: These are my greetings, Sir I am greeting them, greeting the Government, greeting the people. Why? Because we are participating here when Jimmy Carter ....

SHRI SYED SHAHABUDDIN (Bihar): This is unprecedented in the annals of our parliament.

SHRI BHUPESH GUPTA: I told Mr. Chairman, Jimmy Carter was pursuing a policy of boycott of the Olympic Games and it had met with a fiasco because not only the third world countries, not only our own countryof course, it is very natural—but even some NATO countries are participating in the Olympic Games. Sir, we have contributed towards this triumph international games and international co-operation as a Government, as country and as a people. That is what I am congratulating them for. you don't get upset by the name of President Carter.

THE VICE-CHAIRMAN (SHRI R. R. MORARKA): No, I am not upset.

SHRI BHUPESH GUPTA: I will finish it, Sir, I am very glad, Sir, President Carter's policy οf blackmail of pressure. of activities to sabotage the Olympic Games has met with defeat because the spirit of international sport and the Olympic Charter prevailed over such mischief. bell rings). I know, Sir, that you will ring the bell-because I am on a very delicate subject. President Carter wanted to introduce cold war politics into sport, thereby spoiling both politics and sport. He has failed. are happy that he has failed.

THE VICE-CHAIRMAN (SHRIR R.  $MORARKA)_{:}$  Please conclude now.

Now, Sir, I end by saying that we are happy particularly that we are sending a team along with many leaders of various political parties and individuals; and to them we give our best wishes. Sir, I am particularly happy that after the fiasco of the United States President Carter in Iran and Kampuchea—whose recognition by this Government I heartily welcome-they have suffered another defeat in the field of the Olympic Games. These are the words of greetings coming from the heart of Indian patriot. Sir over such matters we as a nation are united. It is our national policy, not a party policy. Hence on this momentous occasion I send my greetings to the Soviet Olympic Committee. The Games are taking place in India's friendliest country. I am sure all men of goodwill will join me in sending our greetings and felici... tations to the team and to the Olympic Committee, (Interruptions).

SHRI SYED SHAHABUDDIN: I think it is a most unprecedented statement made.
