[Shri Kalyan Roy]

(c) the nature and quality of control exercised by the lending institutions on the borrowers' activity, because you have said the IDBI and IRCI have set up a special cell... (Time bell rings) Sir, I would take just a minute or two and finish.

Sir, they have created a special cell. I will read out their report. "Report on the problems of sick units'-"The banks must strengthen their information system...." "The committee has suggested that IDBI as a premier termlending institution, should take the lead to evolve a package scheme of relief to sick units..." and they should go into all this and should have full coordination. But that has not worked at all. The thing is it has been misapplied, misutilised. These are at only on paper. If you want to be effective there is no other way. Let us have a parliamentary committee who can really go into it; have a Commission, have a committee. I have pressed here for a committee as advised by some of my elderly and able parliamentarians. Have a committee consisting of experts and Parliament Members to go into this because the PAC and the PUC cannot go into this, and give a report within six months suggesting suitable remedial measures. Why are you afraid of? Why are you shy? What prevented you from taking suitable measures? You have said and I again read: Those who misuse the institution of funds, make their units sick and then seek take-over should be immediately punished. You have said it. So, to prove the correctness of what all you have said in Calcuttaunless you say one thing in Calcutta and another thing in Delhi, I do not know-please accept the suggestion. I again plead strongly and I hope I will get the support of all Members of this House that a committee should be immediately set up to go into all the frauds and crimes of the public institutions, the IDBI and so on.

SHRI SANKAR GHOSE (West Bengal): Mr. Vice-Chairman, Sir, the honourable Member, Shri Kalvan Roy, has brought a very important question before this House.

He has raised the question about the entire credit policy of the Government. The Ministries concerned with

regard to this matter are the Ministry of Industry, the Ministry of Finance and the Ministry of Company Affairs. Now, I am glad to see that in the absence of the Minister of Finance, the Minister of Communications is ably representing the Ministry of Finance and in the absence of the Minister of Company Affairs the Minister of Information and Broadcasting is representing the Ministry of Company Affairs in the House.

THE MINISTER OF COMMUNI-CATIONS (SHRI C. M. STEPHEN): We both are in charge of communication.

SHRI SANKAR GHOSE: Yes; both of you are in charge of communication. And what has happened to the communication between the management of the sick industries and the financial institutions? It has failed and, therefore, it is good to see that the Minister of Communications has come to rectify the defect. Now, Sir, so far as the credit policy of the Government is concerned . . .

SHRI KALYAN ROY: I can assure vou that the Information and Broadcasting Minister is here and he will see to it that whatever is said here is completely blacked out from the All India Radio.
