## CALLING ATTENTION TO A MAT-TER OF URGENT PUBLIC IMPOR-TANCE

Accident in Palasthali Coal Mine hi Bihar under Eastern Coalfield Limited on 9th June, 1980.

SHRI HARKISHAN SINGH SURJEET (Punjab): Sir, I call the attention of the Minister of Energy and Coal to the accident in the Palasthali Coal Mine in Bihar under the Eastern Coal-field Limited, on the 9th June, 1980, resulting in the death of four workers and injuries to many others.

THE MINISTER OF ENERGY AND COAL (SHRI A. B. A. GHANI KHAN CHAUDHURI): Sir, it is indeed with great distress that I have to inform the House of the unfortunate accident which occurred on 9-6-1980 at about 8.15 A.M. at the Pallasthalli Colliery, an opencast mine of Santhal Parganas in Eastern Coalfields Ltd. It is reported that as a result of continuous rain which began on the 8th June there was a land slide of alluvium, from the Coal Bench as a result of which one Smt. Maino Kisko, aged 29 years, a piece rated worker was killed on the spot and two other workers both Overburden removers were buried under the debris. Their bodies were subsequently recovered. Besides three workers who tragically lost their lives, four others were injured and admitted to the Central Hospital, Kalla. They are reported to be out of danger.
